- 2. Only holders of Ordinary Shares, or their duly appointed representatives, are entitled to attend, speak and vote at the AGM. A member so entitled may appoint (a) proxy(ies), who need not be (a) shareholder(s), to attend, speak and vote on his/her behalf.
- 3. If you wish to appoint someone other than the Chairman of the AGM as your proxy, please insert his/her name in the space provided and delete 'the Chairman of the meeting, or'. A proxy need not be a shareholder of the Company, but must attend the AGM in person to represent you. Changes to entries on the ordinary register after 6:30pm (UK time) on 10 May 2022 shall be disregarded in determining the right of any person to attend or vote at the AGM (unless the AGM is adjourned in which case the previous provisions of this Note 9 apply).
- 10. To be valid, the Form of Proxy must reach the Company's Registrar, Equiniti Limited, by no later than 11:00am (UK time) on 10 May 2022 or, if the AGM is adjourned, 48 hours before the time for holding the adjourned AGM (excluding non-working days). Lodgement of a Form of Proxy does not prevent a member from attending and voting at the AGM in person. Failure to deposit, receive or deliver the appointment of a proxy in accordance with these requirements shall entitle the Company to treat such instrument as being invalid save that the directors may, in their absolute discretion, treat such an instrument as valid notwithstanding any default in complying with these requirements.
